## Wording for Wills & Trusts

### 1) An UNRESTRICTED or UNDESIGNATED gift of money or property:

I give to THE SALVATION ARMY, { address and city of The Salvation Army location to receive gift}, an Illinois Corporation, the sum of (amount written) dollars (\$\_\_\_\_\_ ), or \_\_\_% of my estate, (if you are putting in property, describe same), to be used in such manner as its Board of Trustees determine advisable for the benefit of THE SALVATION ARMY.

### 2) A RESTRICTED or DESIGNATED gift:

I give to THE SALVATION ARMY, {address and city of The Salvation Army location to receive gift}, an Illinois Corporation, the sum of (amount written) dollars (\$ ), or % of my estate and/or (property described) for the specific purpose of, exclusively for, for the sole purpose of, etc ... (then describe area/program: senior citizens or youth programs, alcoholic rehabilitation, evangelism, feeding or housing programs, training of officers, etc.), or as its Board of Trustees determines if said program does not exist at the time of distribution.

### 3) A Memorial Fund:

It may be written either as an unrestricted or a restricted gift, then just add what you would like the fund to be called.

I give to THE SALVATION ARMY ... dollars {or percentage} of my Estate to be known as the {Joe Smith} Memorial Fund. If restricted - describe.

### 4) A Residuary Bequest

Provides for The Salvation Army to receive whatever remains of an estate after all specific bequests have been fulfilled.

I give to The Salvation Army of {address and city}, an Illinois Corporation, all the rest, remainder and residue of my Estate, to be used as its Board of Trustees determines - (or for a specific designation).

### 1) An Unrestricted or Undesignated gift of money or property:

### 2) A Restricted or Designated gift:

I give to THE SALVATION ARMY of Western Michigan with Divisional Headquarters at 1215 East Fulton, Grand Rapids, Michigan, 49503, the sum of (amount written) dollars(\$\_\_\_\_\_ ), (or \_\_\_\_% of my estate and/or property described), for the specific purpose of (describe program: senior citizens or youth programs, alcoholic rehabilitation, evangelism, feeding or housing programs, training of officers, etc.), or as its Board of Trustees determines if said program does not exist at the time of distribution.
